Terms of MoU: This MoU is effective upon the day that both the parties date, sign and execute the MoU. This MoU may be terminated, without cause


by the leaders of either party upon 30 days written notice which shall be delivered by hand or by e-mail.

Scope of Co- operation :


- a) DACL (Movie Club) shall allot membership to select students.
- b) DACL shall arrange suitable location with sufficient facilities for screening of movies.
- c) AFSL shall arrange for screening of select movies that shall inculcate taste and awareness among DACL (Movie Club) members.
- d) AFSL shall also arrange for experts to comment on the screened movie.
- e) The number of movies to be screened shall limit up to 3 in one semester.
- f) DACL shall permit the select members of AFSL to attend the movie screening.
- g) Both DACL & AFSL shall name a representative to co- ordinate the events.
- h) There is no financial transaction involved in any of the events organized.

Amendments : Either party may request change to this MoU. Any change, modification, revision or amendments to this MoU which are mutually agreed upon by and between the Parties of this MoU shall be incorporated in writing and will be effective when executed and signed by the Parties to this MoU.


