The Terms & Conditions (hereinafter referred as "Policy") of your employment with Company contained herein must be read as a part of all the Company's current policies. Your services will be governed by the terms and conditions of employment, policies of the Company, operational instructions and procedures as amended from time to time. This policy supersedes all verbal communications, implicit understanding you may have during the selection process.

8. Remedies on Breach
