As per the policy of the Govt. of Maharashtra, the sanctioned full-time approved posts of teachers that are vacant are recruited for the academic year on Clock Hour Basis on purely temporary basis. The vacancy of the Clock Hour Basis posts is authenticated and sanctioned by the Regional Joint Director Office, Govt. of Maharashtra. Such posts are duly advertised and filled mandatorily from the qualified candidates (NET/SET/PhD) for the academic year and are duly approved by the University and remunerated as per the regulations laid down by the Govt. of Maharashtra. The teachers appointed on the Clock Hour Basis against the posts duly sanctioned by the Govt. of Maharashtra and approved by the parent University discharge all academic duties such as Teaching, Paper Setting, Evaluation ( Internal and External) and also contribute to the co-curricular activities during the academic year.

B. As per SOP A full-time teacher is one who is employed for at least 90 per cent of the normal or statutory number of hours of work during the year.

C. A teacher employed only for a part of a year not to be considered.

D. Inclusion of part-time/ Ad-hoc/ visiting faculty not taking at least 90% of the normal or statutory number of hours of work not to be considered as full-time teacher.
